Did any of us we lose our focus? We all can. Remember our intentions and continuing to try is an accompaniment.

Have you ever asked someone if they could pray for them? Or maybe someone asked if they could pray for you? What did you say? Has our prayer time every been interrupted? Have we have forgotten to pray entirely? We have all forgotten to pray at one time or another in our lives. We lost focus, we lost focus on God. Do we struggle with our prayer life? In Isaiah 26:3 reminds us that when we keep our minds focused on God, our healer and sustainer, we can then find peace: "You will keep in perfect peace those whose minds are steadfast, because they trust in you." The prophet reminds us to place our "trust in" the one who is faithful and able to provide what we need (V. 4).

This passage from Isaiah pointed the Israelites to God's promises during and after their exile. They would sing songs of praise to Him again as they clung to their faith and hope in what He would provide. And the prophet's words also remind us that whatever pain we may endure, we too can find comfort as we focus on trusting in God and calling out to Him.

As we head into February lets focus more on God and less on our frantic lives. Can we turn our concerns into praise and prayers to God.

This month we start the Lenten services, I encourage all of you to join us on Wednesday February the 18th. Dinner begins at 6:00 and the Lenten service starts at 6:45.

Dear God, please remind me to keep my mind focused on you, regardless of what situations I face. AMEN.

Council Meeting Minutes

December 17, 2025

Call to Order: Council President, John Fineran opened the meeting at 7:35 PM.

Council members in attendance were Josie Krohnke, Roberta Jepsen, Leisha Kragel, Seth Neubauer and John Bahnsen . Tammy Neubauer was also present. Jill Sedore and Kirk Manchester were absent.

Opening Prayer: John F. opened the meeting with a prayer.

Approval of Minutes: A motion was made to approve the minutes from the November 19, 2025 meeting. The motion was seconded. Motion carried.

Approval of Financial Report: A motion was made to approve the financial report. It was seconded. Motion carried.

Bills to be paid: A motion was made to pay the December bills. It was seconded. Motion carried.

Committee Reports:

CE: No report was given with Jill's absence, but it was noted the Christmas program was very nice. Jessica is working on a lock-in for the youth in January.

CSFD: They have helped needy families recently and also donated to the Emergency Winter Clothing Fund at the Schleswig School.

CSFI: No meeting.

Property: The electronic sign is not working again. They are waiting for repairs. John F. relayed that he was approached about snow being pushed into the drive after the parking lot was pushed. We need to refrain from having that happen.

Outreach: The meal at Santa Day raised just over \$400 for Outreach projects. The meal and trip to

Walk through Bethlehem that the committee organized was well attended and really enjoyed by those attending.

Stewardship: No report

Endowment: No report.

Pastor's Report: Council reviewed the report submitted, listing visiting elderly, giving communion and attending meetings. It also listed he will meet with the CCMA committee. The report listed he is looking at Lenten material as well as working on his annual meeting report and planning future confirmation classes. It was noted that he did not give communion as listed or attend the Walk through Bethlehem that was listed since he has been sick.

Old Business:

Christmas Eve Service: Roberta, Leisha and John D. will be at Christmas Eve service to take care of council duties. Leisha will do tech. There may be special music.

Plans for Lent: A light meal will be served at 6 PM, followed by a service at 6:45. Council will serve on Ash Wednesday. Members are researching possible meal ideas with final menu plans being made at the January meeting.

New Business:

2026 Budget: The proposed 2026 budget was reviewed. Seth made a motion to approve it, with John B. seconding . Motion approved. Tammy discussed a rough budget for the JAC Farm account that she had prepared. As the general budget increases each year, without a matching increase in the general fund income, it will likely be necessary to use more funds from the JAC account to meet expenses.

Annual meeting organization: John F. will conduct the 2025 annual meeting. Tammy will prepare an agenda for the meeting.

Farm Leases: There was discussion about the current farm ground. It was noted that the trees need to be cut on both properties. As the leases state, this is the renters responsibility. Also as the lease states, the soil samples for the farm Hargens operate have not been turned in by the December 15 deadline. Seth will contact both renters once again about getting these things done. Correspondence from Farm Service Agency was received that the property farmed by Ullrich's has been sod busted and an extra 4.66 acres has been put into production. This was not reflected in the new lease that was just signed. Seth will discuss this with them and see if they plan to reseed the waterways. It was noted it is our duty to see that the ground is well cared for and the lease terms are observed.

Consent Agenda: Tammy discussed how a consent agenda works and the possibility of adding consent agenda items to the future agendas to reduce the length of meetings. It was explained this will ONLY work if each council member reviews their council packet prior to the meeting time. Council would like to give this a try, beginning with the February 2026 meeting.

The next meeting will be January 21, 2026 at 6:30.

With no further discussion, a motion was made to adjourn and was seconded. The Lord's Prayer was recited and the meeting was adjourned.
